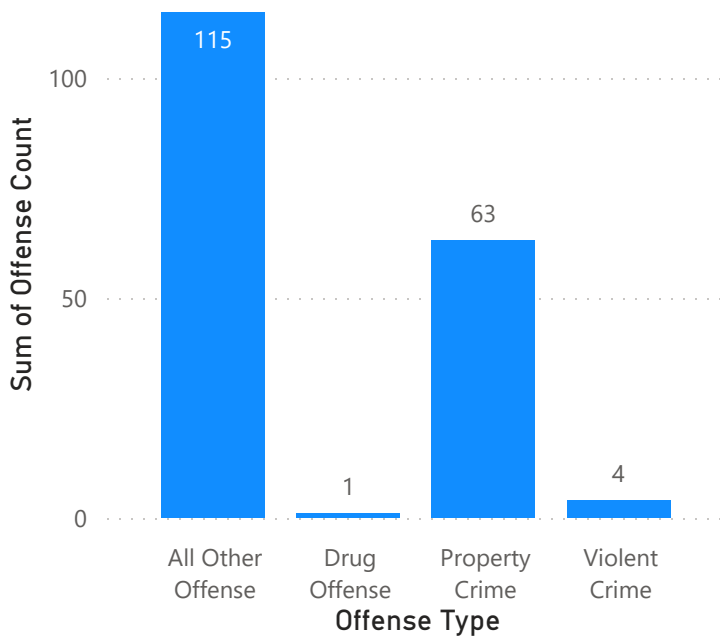

## Arrest Count by Year



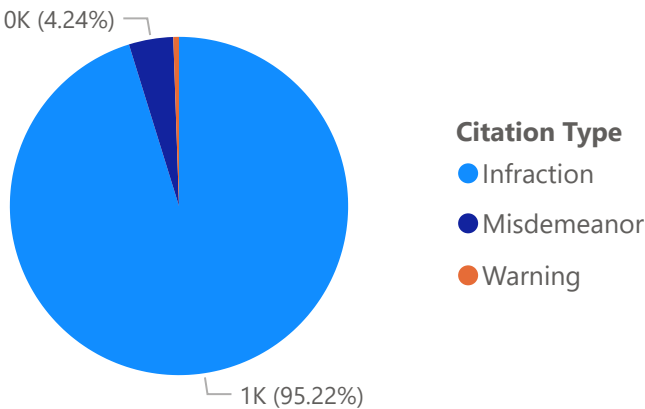

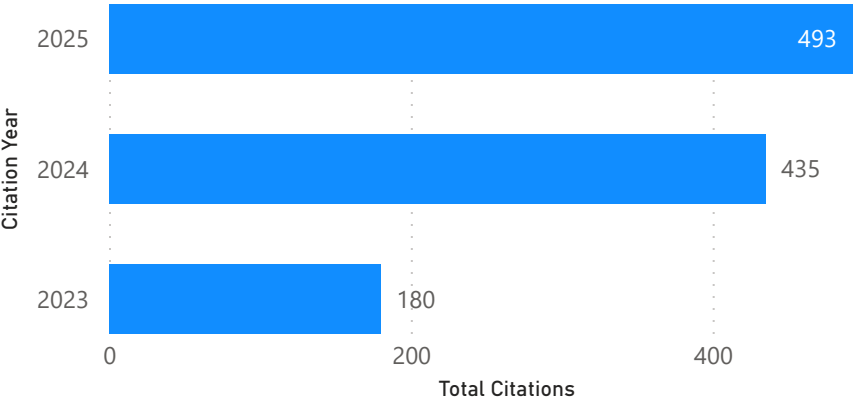

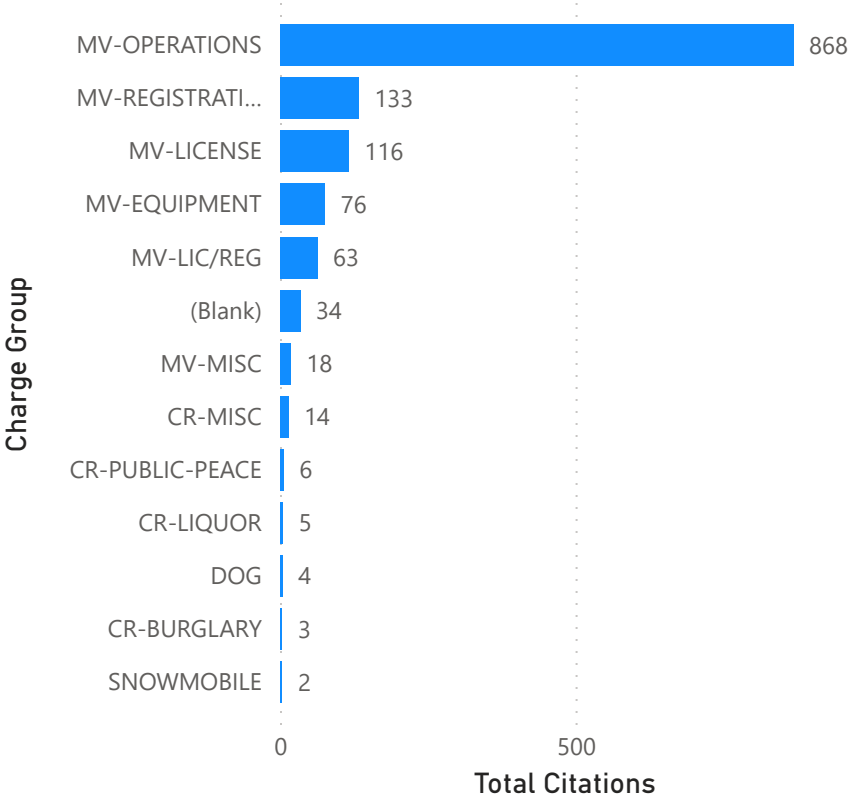

Total Citations by Charge Group



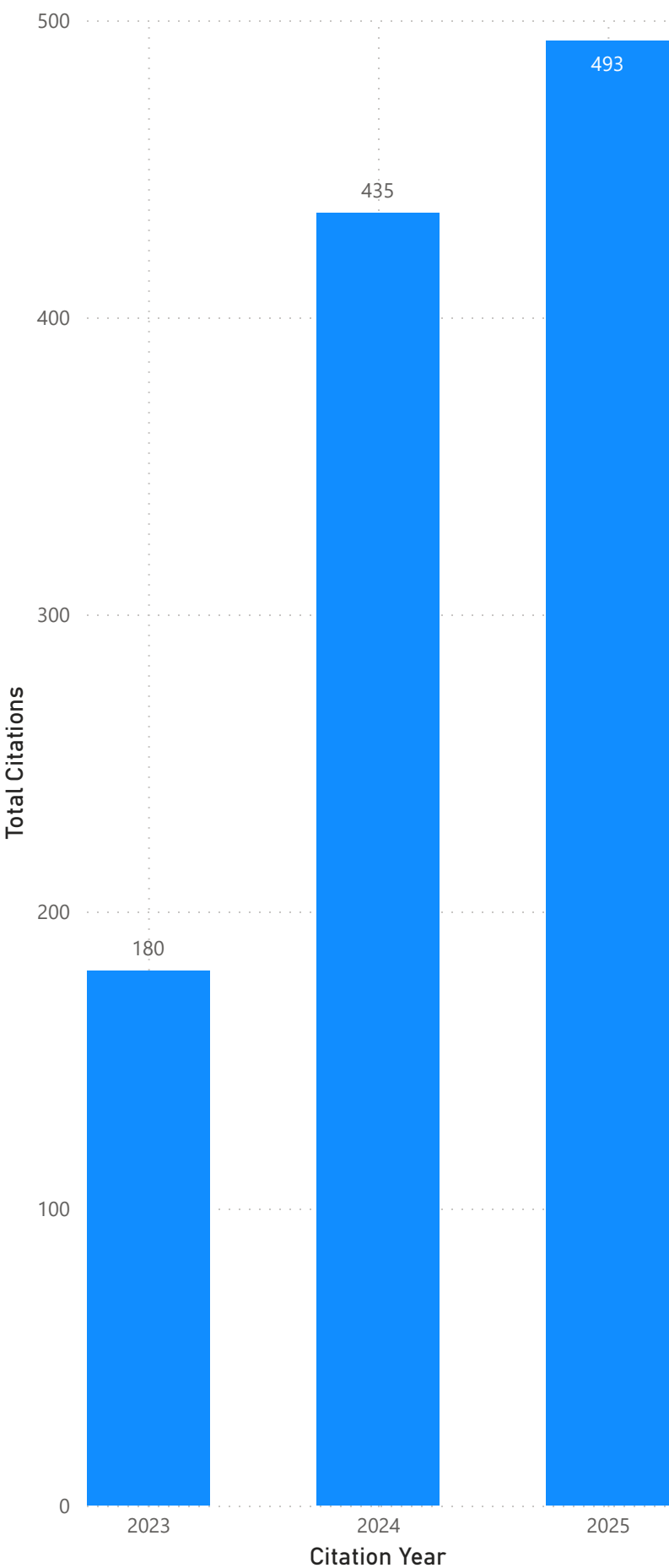

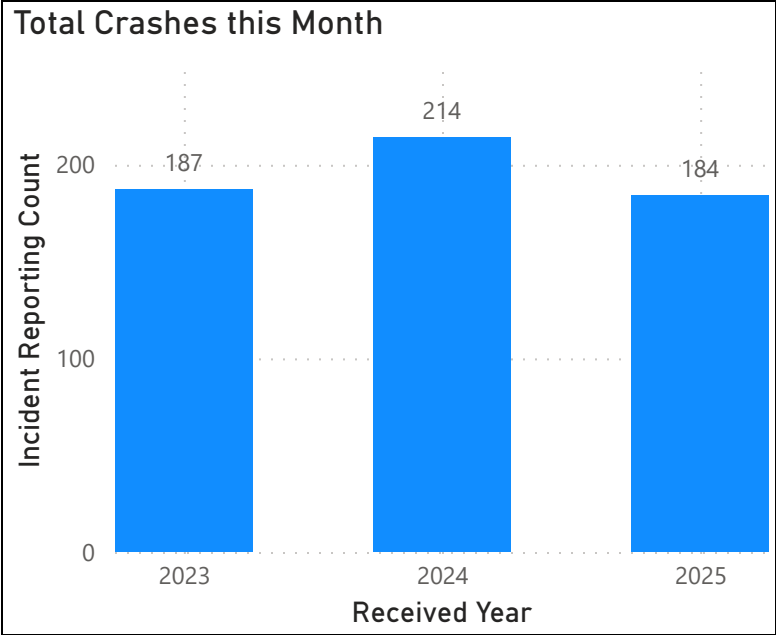

The following is a summary of the proactive work completed during this month by the respective units noted below. Additional details and/or statistics may be found on other pages of this report. This page is intended to serve as a summary and to recognize the dedication of each unit's personnel.

## Traffic Safety & Crash Investigation Units

Traffic Unit Officers conducted a total of 510 traffic stops during the reporting period, leading to the issuance of 386 infractions and 2 misdemeanor summons for various violations.

Crash Investigation Unit reports that the AI team responded to a total of 47 crashes, 11 MV Crashes with Injury, issued 12 infractions, as well as executing 2 search warrants and 1 arrest warrant. The Crash Investigation Unit responded to and investigated a fatal motor vehicle collision at the intersection of Post Road and South Benson Road, as well as a serious motor vehicle crash on Hulls Farm Road. The unit also provided mutual aid to the Bridgeport Police Department. Additionally, the unit assisted the Connecticut State Police CARS Unit with a serious motor vehicle crash on Route 8 in Bridgeport.

## Marine Unit:

Marine Unit logged a total of 103 hours underway, participating in 3 community events and conducted 39 location checks for the month of June 2025. In addition to providing several family boat/auction rides during the month of June, the Marine Unit provided Mutual Aid to Bridgeport for their firework display, security perimeters for the Port Jefferson Ferry Company at the request of Homeland Security and several water rescues/assist during the month of June 2025.



# School Safety Division - June

The School Safety Division is responsible for creating a physical presence at assigned school(s) and school related events. School Safety Officers serve as an informational resource to staff, students, and parents on safety information and interpretation of law. The division is also responsible for the implementation of new safety and law curriculum and to serve as an educator to the student population at assigned schools. It further aides in enhancing physical security and security procedures at assigned schools and periodically assessing, identifying and reporting vulnerabilities at assigned schools.

The School Safety Unit Officers responded to a total of 349 incidents or calls for service and participation in more than 21 school and community events across multiple campuses. Our offices remained highly engaged attending graduation ceremonies for all 17 public schools, participated in the Law Enforcement Torch Run for Special Olympics and Scholarship Award ceremonies at both Fairfield Warde High School and Fairfield Ludlowe High School.

- Working with FPS to implement new visitor management and emergency management systems.



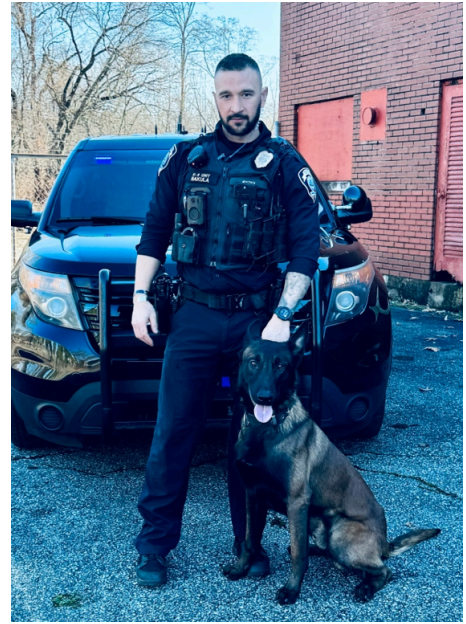

The Fairfield Police Department is once again offering its popular STEP (Student Tools for Emergency Planning) program this summer for students ages 9 to 11.

This free, 2 hour, drop off class introduces students to the basic of emergency preparedness through hands on activities, interactive lessons and a tour of both a police car and a fire truck. Each participant will also build their own emergency supply kit to take home.

There are 6 available sessions for participants to choose from, all hosted at Fairfield Police Headquarters. The program is led by the Fairfield Police Department's School Safety Division and is based on FEMA's nationally recognized curriculum.

The Fairfield Police Commission has awarded the Unit Citation to four members of the Fairfield Police Department for their exceptional work in the investigation following the Stop & Shop parking lot takeover incident in May.

Their efforts included reviewing social media videos, analyzing security footage, and applying for search and arrest warrants. ## Fairfield Police Execute Search Warrant, Arrest Three on Bond Street

Over the course of several months, the Fairfield Police Department received numerous complaints regarding a residence on Bond Street, involving disturbances, breaches of peace, suspected drug sales, and other quality-of-life issues. In response, the Detective Bureau launched an investigation into the property, focusing on the suspected drug activity.

Detectives from the Fairfield Police Quality of Life Unit worked with our States Attorney's Office and obtained a Search Warrant for the residence due to continued drug sales. A search warrant service was executed on the morning of 6/25/25 by the South West Regional Emergency Response Team, Fairfield Detectives, and Bridgeport Taskforce Officers. During the search, detectives seized a quantity of illegal drugs, which included: crack cocaine, ecstasy, Adderall, and fentanyl.

Additionally, the following individuals were arrested:

- Sarah Nuccitelli (36) was arrested for Possession of Narcotics and released on a Promise to Appear in court on 7/9/2025.
- Joseph Gombas (33) was arrested for four outstanding warrants and was on a court-set bond of \$200,000, and issued a court date for 7/9/2025.
- Christopher Gilbert (24) was arrested for Possession of Hallucinogenic with Intent to Sell, Possession of Crack Cocaine over ½ oz, Possession of a Controlled Substance with Intent to Sell, Possession of Drug Paraphernalia in a Drug Factory, was held on a \$100,000 bond and issued a court date of 7/9/2025.

The Department remains committed to addressing quality-of-life crimes in Fairfield. We take all community concerns seriously and will continue to proactively investigate and hold accountable those whose actions negatively impact the safety and well-being of our neighborhoods.

Fairfield Police Department wants to remind all boaters, kayakers, paddle boarders and all water vessel users to wear a life jacket while enjoying Fairfield's beautiful waterways.

Children 13 and under are required by law to wear a life jacket, and everyone else must have one readily available in case of an emergency.

Fairfield Police has a Life Jacket Loaner Station located just outside the Marina Police Building. This allows people to borrow one at no cost through our partnership with Sea Tow.

The Fairfield Police Marine Unit is out on the water throughout the season, conducting safety inspections, ensuring compliance with boating laws and helping to keep everyone safe while enjoying the sun.

On Saturday, June 21, 2025, at approximately 9:30 PM, the Fairfield County Regional Dispatch Center received multiple 911 calls reporting a serious crash at the intersection of Post Road and South Benson Road involving a passenger vehicle and a moped.

Despite lifesaving efforts at the scene, the moped operator, identified as Juan Otilio Tista Tista, age 25 of Bridgeport, later succumbed to his injuries at a local hospital. The Fairfield Police Department extends its deepest condolences to Mr. Tista Tista's family and loved ones during this difficult time. Due to the serious nature of the crash, the Fairfield Police Department's Crash Reconstruction Unit responded and assumed the investigation.



The investigation revealed that Antony Gutierrez Silva, age 16 of Bridgeport, was operating the vehicle that struck Tista Tista, who was operating the moped. Gutierrez Silva was traveling westbound on Post Road and attempted to turn left onto South Benson Road. In doing so, he entered the path of Mr. Tista Tista's moped, which was traveling eastbound in the right lane of Post Road.

Immediately following the collision, Gutierrez Silva fled the scene without rendering aid or notifying authorities. A witness to the crash attempted to follow him; however, as Gutierrez Silva tried to evade the witness, he struck the witness's vehicle and fled the scene without stopping, resulting in a separate evading incident. Later that evening, members of the Crash Reconstruction Unit located Gutierrez Silva at his residence in Bridgeport. His vehicle was also located and seized as part of the ongoing investigation.

As a result of this investigation, the Fairfield Police Crash Reconstruction Unit has filed the following charges against Antony Gutierrez Silva:

- Negligent Homicide with a Motor Vehicle
- Operating a Motor Vehicle without a License
- Passenger Restrictions Violation
- Failure to Grant the Right of Way While Turning Left
- Evading Responsibility Resulting in Death
- Evading Responsibility (Property Damage)

Although Gutierrez Silva is 16 years old, he is being charged as an adult under Connecticut law, as motor vehicle offenses are not considered juvenile matters.

The Fairfield Police Department would like to thank the members of the community who promptly reported the crash and those who voluntarily provided video footage to assist in the investigation. We also extend our gratitude to the responding officers, Fairfield Fire Department personnel, and American Medical Response (AMR) staff for their swift response and professionalism.

### **Officer Nicholas Ardizzone**

On June 10, 2025 FCRD received a 911 call reporting a two- vehicle crash with injuries. Upon arrival, patrol officers determined that the operator of one of the vehicles had fled the scene on foot.

Due to the mechanism of injury and the fleeing operator, Officer Ardizzone was called in while off duty to assist with a K-9 track. Officer Ardizzone and K9 Bolt conducted a track in the area and successfully located a male subject lying on the ground behind a shed near Old Black Rock Turnpike and Black Rock Turnpike. The male was found unconscious among several pieces of wood. he was identified as the operator who had fled the scene.

The individual was detained and transported to the hospital for evaluation and treatment of his injuries.

Officer Ardizzone's swift response and effective K9 track led to the successful apprehension of the suspect. His efforts not only resulted in an arrest but also ensured the operator received necessary medical attention, potentially preventing a more serious outcome.

### **Officer Sara Ball and Officer Walter Burke**

On Friday, June 19, 2025, members of the Fairfield Police Department responded to a critical water rescue incident at 589 Fairfield Beach Road involving an unresponsive male who had been pulled from the Long Island Sound. Officer Ball was among the first to arrive on scene and immediately began providing lifesaving care, taking over CPS efforts and working alongside other first responders in an attempt to resuscitate the victim. Officer Ball demonstrated calm professionalism and a clear commitment to preserving life under extremely urgent conditions.

Shortly thereafter, Officer Buke responded aboard a Fairfield Police Marine Unit vessel to support the ongoing rescue operation. His rapid deployment and coordination with emergency personnel further ensured that the victim received immediate and comprehensive medical attention.

The courageous actions of both officers - though independent in response - were united in purpose and demonstrated exceptional dedication to duty. Officer Ball's immediate life-saving efforts and Officer Burke's support from the Marine Union reflect the highest standards of service and teamwork.

Their performance during this emergency reflects great credit upon themselves and the Fairfield Police Department and exemplifies the values of courage, commitment and public safety.

### **Detective Michael Zerella**

Over the course of several months, the Fairfield Police Department received numerous complains regarding a residence on Bond Street, involving disturbances, breaches of peace, drug sales and other quality-of-life issues.

Detective Zerella was the lead investigator on this 6-month narcotics investigation that successfully concluded with three criminal arrests, seizure of Crack Cocaine, Ecstasy, Adderall, Fentanyl and \$7,600 cash.

Once again Detective Zerella's hard work, attention to detail, and perseverance were the driving force in being able to keep on tack a lengthy and complex narcotics investigation that involved a number of different dealers and users.

This investigation involved undercover physical and electronic surveillance, witness statements and the use of confidential informants. Many hours of physical surveillance at the residence as well as mobile surveillance in a number of jurisdictions throughout Fairfield County were spent that helped gather intelligence and evidence.

Detective Zerella was primary investigator and coordinated detectives, patrol officers and other agencies taskforce officers in order to gain intelligence and PC for search warrants at the residence.

Detective Zerella brings a large amount of training and experience conducting narcotics investigations to this agency. We are lucky to have a detective with his experience and dedication. He is consistently conducting very thorough investigations that have a positive effect on the department and the citizens of the town of Fairfield.

### **Detective Michael Clark**

On 9/16/24 at 1130 hours the Fairfield Warde High School administration office received an anonymous call from an unidentified person who stated that there was a bomb in the school. The only information obtained during the initial phone call was that the voice appeared to be from a male and there was a phone number obtained through caller identification. School Resource Officer Wilkie and administrators conducted a sweep of the school and the on-scene investigation revealed that this was not a credible threat. However, these "Swatting" incidents can be incredibly dangerous and are done with the intention to harass and terrorize a specific group of people. It was determined that the phone number associated with the call originated from Summerville, SC.

Detective Clark was assigned to follow up with the investigation. Detective Clark is a certified Mobile Phone Examiner, Certified Physical Operator, and a Certified Physical Analyst through Cellebrite. He also served for two years as a Sworn Special Deputy US Marshal under the FBI Cyber Division and three years under the US Secret Service sponsored digital forensic lab.

Detective Clark conducted an incredible thorough investigation, in which, he used multiple investigative tools to identify the source of the phone number and IP address associated with it in South Carolina. Through this process a juvenile male suspect was identified. Over the course of several months Detective Clark coordinated with the South Carolina FBI Office and the Berkley County Sheriff's Office. This effort resulted in the Berkley County Sheriff's office obtaining a confession from the suspect.

Detective Clark then coordinated with the mother of the suspect and the CT Juvenile Supervisory States Attorney. This resulted in the male juvenile arriving in Connecticut on 06/04/25 with his mother where he was charged with Threatening 1st Degree stemming from his involvement in this incident.

More often than not the perpetrators of these types of incidents are rarely held accountable for their actions due to the jurisdictional limitations of local law enforcement. Because of Detective Clark's dedication to this investigation and his ability to coordinate with multiple law enforcement agencies the suspect in this case was identified and properly charged. As his direct supervisors I feel that he should be officially recognized for his effort.
