



Arrest Count this Month Only















Traffic Safety & Crash Investigation Units

School Safety Division - May

The School Safety Division is responsible for creating a physical presence at assigned school(s) and school related events. School Safety Officers serve as an informational resource to staff, students, and parents on safety information and interpretation of law. The division is also responsible for the implementation of new safety and law curriculum and to serve as an educator to the student population at assigned schools. It further aides in enhancing physical security and security procedures at assigned schools and periodically assessing, identifying and reporting vulnerabilities at assigned schools.

The School Safety Unit Officers responded to a total of 543 incidents or calls for service and participation in more than 20 school and community events across multiple campuses. Our offices remained highly engaged and visible in schools, providing instruction, facilitating safety drills and supporting events ranging from proms and concerts to Bike to School Days and educational presentations. As the school year winds down, the School Safety Division is preparing for the transition to summer. The upcoming responsibilities will include STEP courses, security assessments, and site and security checks at school campuses hosting camps, programs and special events. These efforts will help maintain safety and readiness throughout the summer months.





May is recognized nationally as Mental Health Awareness Month, and the Fairfield Police Department reaffirmed its commitment to supporting wellness initiatives within the community and addressing mental health-related challenges with compassion, professionalism and care. Fairfield PD understands individuals experiencing mental health crises may sometimes come into contact with law enforcement. When those situations arise, our goal is respond with empathy, patience and a deep understanding for the unique needs of those involved.

To that end, the department has developed and maintained a Crisis Intervention Team, comprised of officers who have received specialized training to safely and effectively respond to calls for service involving mental or behavioral health issues. These officers are equipped to de-escalate situations and connect individuals with appropriate resources.

Additionally, the Fairfield Police Department is proud to have a licensed social worker embedded within the agency. This social worker assists in handling cases that originate through police calls for service and provides ongoing support to individuals and families facing mental health challenges.

In 2022, the department formalized its commitment to integrated mental health response by creating the Fairfield Police Behavioral Health Network. This network meets on a quarterly basis and brings together the department's embedded social workers, members of the Crisis Intervention Team, and other stakeholders to review current practices, discuss recent cases and identify way to better serve the Fairfield Community. The Fairfield Behavioral Health Network serves as a forum for continuous improvement, collaboration and innovation in how law enforcement and mental health services intersect.

The network brings togethers experts from:

- DMHAS
- Greater Bridgeport Community Mental Health Center
- Child and Family Guidance Center
- Mobile Crisis Intervention Services
- Operation Hope
- Fairfield Senior & Social Services



As part of our continued efforts to lead in this area, the department is also expanding its mental health support program by introducing a social work intern. This position is designed not only to provide additional assistance to our current caseloads, but also to serve as a learning opportunity for future social workers. The role represents a growing collaboration between the fields of law enforcement and social work, an innovative model that enhances community support and helps shape the next generations of mental health professionals.

In recognition of Mental Health Awareness Month, the Fairfield Police Department raised funds throughout May to support our Behavioral Health Network. Proceeds will be used to provide continued training for members of our Crisis Intervention Team, assist in offering critical resources to members of the Fairfield Community facing mental health-related challenges, and support programs that enhance networking and outreach opportunities coordinated by our embedded social worker.

Mental Health Awareness Month is a time to reduce stigma, raise awareness and reaffirm our shared responsibility to care for one another. The Fairfield Police Department remains dedicated to promoting mental wellness and ensuring that all individuals are treated with dignity, respect and compassion.



The Fairfield Police Department was proud to host a local Girl Scouts Troop on May 1, as part of the Girl Scout Day in Government; an annual event where Scouts shadow town officials to learn about how local government works.

As part of their visit, the Girl Scouts Troop got an up-close look at our Marine Unit, K-9 Unit, and Motorcycle Unit, and received a full tour of the Fairfield Police Headquarters.

On Friday, May 2nd; at approximately 10:55 pm, a Fairfield Police officer observed a group of individuals and vehicles gathering in the parking lot of Stop & Shop located at 760 Villa Avenue.

As the officer began coordinating a law enforcement response, the Fairfield Police Department was simultaneously managing several significant emergency calls. Due to the nature and urgency of those calls, an immediate full-scale response to the parking lot was not initiated. As there was no active threat to the public, the officer on scene monitored the situation while awaiting additional units to ensure a coordinate and safe approach.

Once the other emergency calls were stabilized, a team of several officers proceeded into the parking lot as a unit. Upon police entry, the crowd and vehicles began to disperse rapidly. It is important to note that this phase often presents heightened risk, as fleeing drivers may accelerate dangerously, endangering both the public and law enforcement officers.

During the response, the Fairfield County Regional Dispatch Center received a report of a possible fire at the scene. Once on scene, officers confirmed there was no longer an active fire and determined that fire department response was not necessary.

Fairfield police actively investigated, and able to apprehend the suspects through the temporary task force "Operations Cars & Consequences."





On May 7th, the Fairfield Police were pleased to host the Greater Fairfield Board of Realtors for an engaging session focused on keeping both realtors and their clients safe. Officers shared valuable insights on a range of topics including internet and financial scams, how to navigate and utilize the Fairfield Police Department's interactive crime dashboard, and practice safety tips for real estate professionals.

On May 24th, the Fairfield Animal Shelter hosted a rabies vaccination clinic that was open to all, regardless of town or state.





On May 10th, the Fairfield Police Department were happy to recognize Captain Paris and Lieutenant Riendeau on graduating from Sacred Heart University with their Bachelor Degrees.

Balancing a full-time career in law enforcement, while pursuing higher education is no small task, and both have accomplished this with dedication and determination. Their commitment to learning reflects the Fairfield Police Department's strong belief in the value of continued education.

In today's evolving world, higher education plays a vital role in modern policing, enhancing critical thinking, communication and leadership skills that directly benefit the communities we serve.

Supervisory Recognition of Personnel

The following personnel were recognized this month for exemplary actions or achievements, regardless of when the incident or effort occurred. This section highlights outstanding contributions by team members who have demonstrated exceptional commitment and professionalism. The content below provides summaries of the actual commendations to emphasize the impactful work that earned these recognitions. Supervisor recognition is essential in building a culture of excellence, encouraging continued dedication, and acknowledging the exceptional efforts of our personnel.

Sergeant William Beattie

On 5/5/2025, Sergeant Beattie responded to a missing person's report. While officers had initially responded to the call, additional personnel responded to assist to include a K-9 handler and Sergeant Beattie.

On scene the complainant stated that she was very concerned as she woke up to find her wife missing. The complainant further stated that her missing wife had recently shown signs of depression.

While officers were investigating and gathering pertinent information, Sergeant Beattie assisted with canvassing the area. As Sergeant Beattie was searching the exterior of the home, he located and opened a closed storage bin located outside in the rear yard. Inside this storage bin, he had located the complainant's missing wife! Sergeant Beattie provided immediate assistance to include administering Narcan. When she was found, she was unresponsive with a pulse. After administering Narcan, she was transported to the hospital to the emergency room and admitted into the ICU. At the hospital, she was intubated and unresponsive.

As of 5/9/2025, she had her tube removed and was able to speak.

There is no doubt that the actions taken by Sergeant William Beattie saved a life that day. This person who was located and saved by Sergeant William Beattie is married with a two year old daughter.

Sergeant William Beattie should be recognized and commended for his actions on that day.

In recognition of their outstanding dedication, investigative excellence and exemplary teamwork, Sergeant John McGrath, Officer Jordan Nadeau, Officer Anthony Renaldi and Officer Nicholas Ardizzone are hereby awarded the Unit Citation for their exceptional performance as members of the temporary task force known as "Operation Cars & Consequences." This task force was established in response to a dangerous and disruptive street takeover incident that occurred in the Town of Fairfield on May 2, 2025.

This incident involved a large group of individuals who engaged in criminal and reckless behavior, including burnouts, fireworks and other riotous activity in a public parking lot, creating a substantial threat to public safety and property. Responding to this challenge, these officers demonstrated exceptional initiative and coordination, working seamlessly with one and another an in conjunction with the State's Attorney's Office and multiple outside agencies.

As a unified investigative team, they identified key suspects and vehicles through advanced techniques including forensic social media analysis, surveillance, inter-agency intelligence sharing and digital forensics. They conducted and executed multiple complex search and arrest warrants, which led to the seizure of high-value evidence and the successful prosecution of several involved parties.

Their actions required not only sound tactical judgment and investigative acumen but also sustained perseverance, legal precision and interdepartmental cooperation. The effort to dismantle this criminal operation was monumental and complex, yet these officers navigated each challenge with professionalism and unwavering commitment to community safety.

The Fairfield Police Department proudly acknowledges the accomplishments of this team, whose work serves as a model of law enforcement excellence and reflects the highest standard of public service. Their efforts significantly disrupted organized street takeover activity in the region and sent a clear message of accountability and proactive policing.
